Complaint: ANNUAL MAINTENANCE AND OPERATIONAL SERVICE INSPECTION OF YOUR EMERGENCY STANDBY GENERATOR.
Cause: SERVICE DUE.
Correction: Drove over to site 2 of 2, and gained entry to the fire pump and control room. Unit was placed on test mode and PM service began on this unit. Oil removed from the unit and the oil and fuel filters were also removed and replaced with new. Added new engine oil to system. All necessary cleaning and lube points were addressed and cleaned up. Removed the coupling housing to check the prop shaft for any deficiencies. Fuel supply line looks to have moisture surrounding a couple of its joints and were wiped down and checked during the engine run. The return also had a couple places where it looked wet from fuel. The raw water emergency side piping is split directly at the regulator and has to be replaced. May not be able to remove the broken piece from the brass so quote replacing both pieces (listed below) The batteries are in very bad shape with 80% of the internal plates look burnt and corroded from lack of battery acid. Cables are corroded at the batteries on all of the connections upon arrival, were cleaned. Quote to follow.
