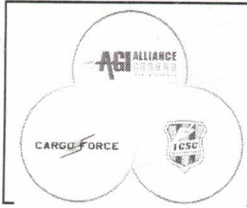

Safety is Job Number 1



Pinch Points

May 16, 2024

Keep fingers, hands, arms, feet, and legs away from possible pinch points. Some safety programs refer to this as the "Bite". Holding on to a dolly tongue by the attachment ring while hooking up to a tug is dangerous because this is in the "Bite" area of the tug/dolly connection and you will eventually get your fingers crushed. Standing between two forklifts, is standing in the "Bite" of the two forklifts. If they were to back into each other, you would surely be crushed. Standing between a moving piece of equipment and a stationary object is dangerous because this is standing in the "Bite" of the equipment and the object. If the equipment didn't stop, where would you go to keep from being crushed? Putting any part of your body between a moving object and a stationary object is dangerous because you are putting your body part in the "Bite" area. What if the equipment falls or moves? I think you're getting the idea. This is relevant on the ramp, in the warehouse, and in the maintenance shop.
