Great thanks! We would go with option 1 with the different inner fabric. Would you be able to send over updated costs for a 2:2 packaging and style numbers?

For the crate containers, would we be able to do 3 full containers and only use the units needed for the set and then use the leftover units for additional flow? Similar to how we work with the MOQs.

For the beds, noted on the Ortho Napper & Hide Mat Large. For the other 2 styles, Hide Mat Med & Tufted Bone Pillow, would you be able to send over updated costs for the 2:2 packaging? We would need a 2:2 to be cross dockable in our DCs. I will also update the buy sheet and any POs/system updates we need for those 2 styles that should be a 2:2. Our FA23 Buysheet reflects all inners as a 1. Are you able to send over a list by style number on what the correct inners and outers should be? For example I have the Hide Mat Large as a 1:2 reflected on the buy sheet and in our system vs it should be at a 2:2. I have attached our FA23 buy sheet for reference.

Thanks for all the updates!

Please see the attached quote sheet for the new plaid beds. There are 2 options for the style with different inner fabrics, costs, and quantities to use the remaining fabric. Let us know which you would like to go forward with and if there are any questions.

Please also see the attached furniture buysheet for clarification on the options of order quantities for 2 or 3 full containers of the crates. You can adjust the store and digital quantities as needed if the total omni units stay the same.

Regarding the case packs of 2:2 for carryover beds, we want to be sure we are clear on this and think it might be helpful to discuss. Do you need inners of 2 rather than 1 to be cross dockable? It seems that inners of 1 have been listed on the buysheet, but are not what we are currently doing for stores. Were they listed that way for Ecom where the inner of 1 with a PE bag is required?

- Ortho Napper – currently 2:2
- Hide Mat Medium – currently 6:6, can do 1:6
- Hide Mat Large – currently 2:2
- Tufted Bone Pillow – currently 4:4, will check on doing 2:2, but there may be an upcharge

Also, I have received pre-production samples of the Tufted Crate Mat, Hands-free Leash, and Carrier. I'll be at Kohl's office on Wednesday morning and can drop them off. Please let me know if you have a little time to meet and review them.

Please see my comments in red below:

- With some of the quantities being low, are you able to provide either additional orders or forecasts for the SP24 season? **Yes, we will work through this to get a forecast by choice**
- Christine noticed some changes on the ticketing/subclass information for carryover items, is that correct? **Correct! The ticket updates reflect our new pricing structure of an everyday low. Once written, the POs will still reflect the old tickets as we cannot update our system until February. The Subclass information was updated as we did a reclass a couple months ago. There was one on your sheet that I had highlighted in yellow with the correct subclass.**
- March and April orders are due by 11/20 due to Chinese New Year. Would you be able to add those orders to the buy sheets now? **Yes, I will send this over when we send the forecasts. We will also be setting the new bed using the leftover slope fabric. Would you be able to send us over those details?**

A couple notes to callout:

- There are 2 options on the Couch because the original doesn't quite fall within Kohl's max carton size requirements. One is adjusting the size spec of the depth slightly and the other is changing the fill from convoluted foam to chipped memory foam.
- For the Crates, we recommend the full color carton and unfortunately after checking with the factory using stickers on kraft cartons isn't going to be a workable option. And, as you called out in our meeting, the kraft box option wouldn't show an actual photography image.

Regarding the case packs of 2 for pet beds, you would like us to check on adjusting the current carryforward Bone Pillows from 4 to 2, correct?
