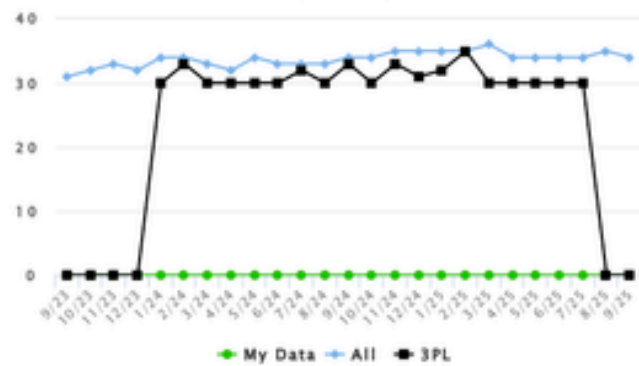

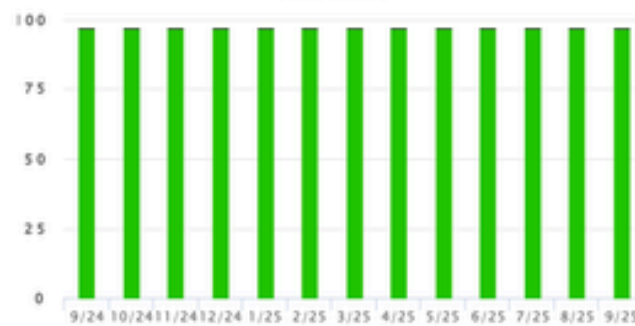
Balance in Dollars
