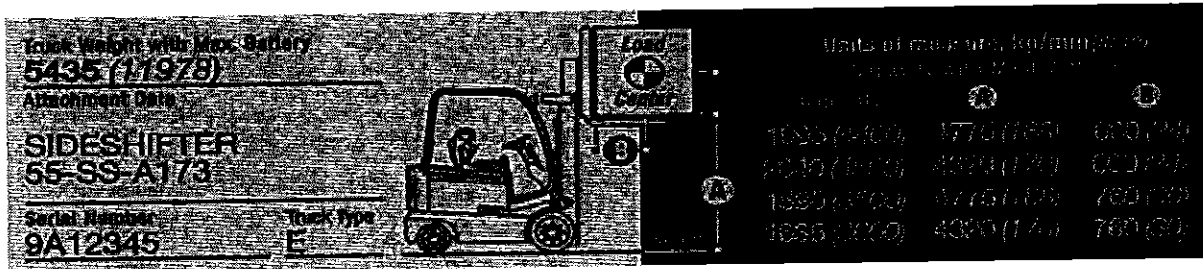

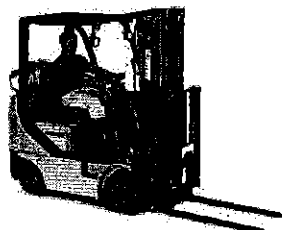

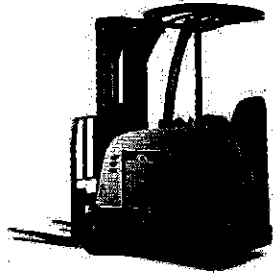

- I will thoroughly complete a pre-use inspection of my personal fall protection harness.
- If visibility is impaired, I will travel in reverse and sound the horn.
- I will not leave the platform of an Order Picker to access the racking.
- I will not pass an Order Picker in the aisles that are elevated while picking.
- I will stop at all stop signs, look both ways and sound my horn.
- I will not leave my equipment unattended, load engaging means shall be fully lowered, controls shall be neutralized, power shall be shut off and brakes set.
- I will not horseplay while operating equipment.
- I will drive at a safe speed at all times.
- I will not enter unauthorized areas.
